I ACKNOWLEDGE THAT THESE EVENTS ARE A TEST OF A PERSON'S PHYSICAL AND MENTAL LIMITS AND CARRIES WITH IT THE POTENTIAL FOR DEATH, SERIOUS INJURY, OR PROPERTY LOSS. I FURTHER ACKNOWLEDGE THAT FIREARM SHOOTING COMPETITIONS HAVE INHERENT DANGERS INCLUDING DEATH, SERIOUS INJURY OR PROPERTY LOSS. WITH FULL KNOWLEDGE OF THE ACTIVITIES INVOLVED, I HEREBY ASSUME THE RISKS OF PARTICIPATING IN THIS EVENT.

By selecting the "I Hereby Accept the Terms & Conditions for this event and have downloaded all necessary documents above" checkbox during online registration, I am acknowledging that this event, firearms (in general), shooting, handling firearms, shooting competitions, and even being at a shooting range (all collectively referred to as "shooting activities") are hazardous activities and that I am voluntarily assuming the risks of participation in such activities with knowledge of the inherent dangers involved, and hereby agree to accept any and all risks of injury or death associated with such activities.
